Section 2: That the FINANCE COMMITTEE for the year 2018 shall consist of the following council members: **Chairman, Don Polyak**, and Council persons, Ron Antal and Ron Fenn.

Section 3: That the PUBLIC SAFETY COMMITTEE for the year 2018 shall consist of the following council members: **Chairman, Ron Antal**, and Council persons, Ron Fenn and Heather Davis. Further, **Ron Antal**, shall be the liaison to the Valley Fire District.

Section 4: That the LANDS AND BUILDING COMMITTEE for the year 2018 shall consist of the following council members: **Janet Miller, Chairman**, and Council persons, Bob Bartko and Ron Antal.

Section 8: That the COMMUNITY DEVELOPMENT COMMITTEE for the year 2018 shall consist of the following council members: **Janet Miller, Chairman**, and Council persons, Heather Davis and Don Polyak.

Section 9: The that the BOARD OF NUISANCE ABATEMENT, shall consist of the Pres. Pro Temp **Don Polyk**, the Mayor, **Bill Goncy**, the Fire Chief, **Charlie Riedel**, and the Zoning Inspector, **Terry Bowlin**.
